Staff are still settling in the new building, and for now, client visits and therapeutic recreation programming remain at the 1830 6th Avenue facility while the Caxton space is being renovated.



Bethany hired **23 more staff members** in the past year! As more children and families suffer from pervasive issues such as poverty, homelessness, and mental illness, the need to unify caseworkers, educators, and financial staff is paramount for effective collaboration.

# Program Spotlight: Intact Family Services

A single, unemployed mother with two young children was referred by the Illinois Department of Children & Family Services (IDCFS) to Bethany's Intact Family Services due to allegations of abuse or neglect. Bethany's Intact caseworker visited her home and ensured that the young mother was connected to local mental health services. She was provided assistance in



arranging and paying for daycare services, which enabled her to secure a full time job and move into her own apartment. The Intact worker accessed IDCFS funds to assist with rent and purchase a bed. This mother successfully completed the Intact Family Services Program and her children remain in her care.

This person's story is not unusual. Many parents become involved with IDCFS following allegations of child abuse and neglect related to mental illness, poverty, substance abuse, domestic violence, or homelessness.

Intact Family Services caseworkers aim to stabilize, strengthen, enhance, and preserve family life by providing services and interventions to ensure children remain safely at home.

Intact Family Services works with parents, children, and the court system to set and meet goals. Families are connected with essential community resources to address underlying issues and ensure child safety. Services are provided in the home with the ultimate goal of safely keeping children in their home environment.



"I love seeing families smile and feel joy when they thought they would fail. I love that feeling when I see the change in the children's faces when their family succeeds in overcoming significant hurdles. This program can change their lives for good," said one of Bethany's Child Welfare Specialists.

Bethany's Intact Family Services provides in-home case management and supportive services to families in Rock Island, Henry, and Mercer counties. The program covers a large geographic region including many rural towns and cities. Requirements of the program include weekly contact in the home for a period of 45 to 90 days and then twice monthly following that initial period.

# MERIT Award Winner: Cyndee Felske

Bethany's MERIT Award Winner for the first quarter of 2023 is Cyndee Felske. Cyndee is a Child Welfare Specialist III in the Foster Care Program. Cyndee has been at Bethany for 23 years.

The nomination stated, "Cyndee has been a great team member. She goes above and beyond her specific job duties on a regular basis. She has actively been working on getting foster care



children permanency through adoption and guardianships."

The nomination also stated, "She consistently provides additional training and help for the new case managers. She is willing to help other case workers who are in a pinch, whether it is faxing/emailing something to a worker or foster parent, looking up information needed by a worker, sitting at a hospital for hours with a youth, or providing a worker with the correct CFS form number."
